It has been great to hit the ground running in 2024, both in my work in the constituency and parliament.

This month, we saw the Government's shameful Safety of Rwanda Bill pass through the House of Commons, despite the fact that I voted against it at every opportunity. At a potential cost of £400 million to the British taxpayer, this Bill is an unworkable waste of time and money. The Rwanda policy does not represent the kindness and compassion that makes my constituency so wonderful, and I completely oppose it. I will be monitoring the Bill's progress in the House of Lords carefully and will continue to do everything I can to prevent it becoming law.

Along with the whole country, I have been deeply saddened by the terrible stories caused by the Post Office Horizon scandal that have come to light recently. While it has been good to see this issue finally getting the attention it deserves, it is a matter of national shame that this scandal was allowed to happen and that affected families are still waiting for justice. These people have waited years and years for a resolution, and sadly some sub postmasters are not here to see justice served. If you are someone who was affected, please do get in touch and I will do all I can to support you.

My campaign to prevent the closure of the maternity unit at the Royal Free Hospital is ongoing — it is something that means a great deal to me as both of my children were born there, and I know that the closure of the unit would have a really significant impact on families in my constituency. This month I have written a joint letter to local health chiefs with Brent councillors, MPs, and Assembly Members explaining why the maternity unit must remain open. # Speaking in a debate on public sector pay

I spoke this month in a Westminster Hall debate on the state of public sector pay. Working people have seen 14 years of low growth, stagnant wages and high taxes. As I said in the debate, the average pay for workers is lower in value now than it was 14 years ago, when the Conservatives first came to power.

I believe that it is the Government's responsibility to ensure that quality public services are provided for the common good of the country and that those who run those services are paid fairly and treated with respect, and I was glad to be able to put this point forward.



# Speaking at the Investing and Saving Alliance Annual Conference

I was delighted to speak at TISA's annual conference. TISA do fantastic work in bringing the financial services industry together to try and improve the financial wellbeing of people around the country.

As I said in the speech, the challenges and opportunities facing Britain in the 21st Century, whether in improving financial education in schools or reforming our fragmented pensions market, will require a new covenant between government and the financial services industry. I am committed to making sure that this partnership is as positive and fruitful as it can be under a Labour Government.



# Visiting the Fairtrade Reception in Parliament

I had the pleasure of going along to a Fairtrade reception in Parliament, where I learned a lot about what Fairtrade does to ensure that producers and suppliers get a fair deal.

More than 1.9 million farmers and workers are in Fairtrade certified producer organisations, meaning that they are guaranteed a fair price for their work. I tasted for myself that treating your suppliers well means that the produce is often better too! These companies make sure that the people they work with get a fair deal, and I will continue to work with businesses and the Government to ensure that good practice can become the norm.



#### Supporting the work of Surviving Economic Abuse

I was proud to visit the Surviving Economic Abuse charity drop-in in Parliament. As Shadow City Minister, I have seen for myself the impact that economic abuse, such as coercive control over income and bank accounts, can have on people's lives. One in five women in the UK has experienced economic abuse by a current or former partner over the last 12 months, and over a third of them didn't tell anyone at the time.

<u>Surviving Economic Abuse</u> are a fantastic charity who fight economic abuse and work to raise awareness around the issue, as well as providing support for victim-survivors across the UK. It's incredibly important that people who have been affected by this awful crime know that support is out there. Often the hardest part is telling someone that you have been affected and I am supporting charities like Surviving Economic Abuse who are making this process easier for so many.



# Supporting the Jo Cox Foundation's campaigning

I was really glad to have the opportunity to show my support for the Jo Cox's Foundation's campaign to ensure that elected representatives are protected and kept safe. There is no place for abuse and intimidation in politics, and we should be doing all we can to ensure that it is a safe environment to encourage people from all backgrounds to get involved. In 2022, it was found that MPs received more than 130,000 toxic and abusive messages in just six weeks. The Jo Cox Civility Commission, set up in the wake of the tragic death of MP Jo Cox in 2016, has some really sensible recommendations for how we can ensure that this is prioritised, and I hope the Government will look seriously at how we can tackle these issues.
